## A MESSAGE FROM THE STATE BAR PRESIDENT



During my term of office, we celebrate the courageousness of a nation that would sign into law, 50 years ago, the Civil Rights Act of 1964 and the Voting Rights Act of 1965. We remember brave foot soldiers in Selma and Birmingham that dared to risk their lives and the lives of their families to ensure their voices were heard in Washington, DC. Many brazenly walked across the Edmond Pettis Bridge in the face of peril seeking the right to vote, justice and the very freedoms espoused in the Magna Carta 800 years ago. Their actions would ultimately propel passage of the Voting Rights Act of 1965. The fundamental rights in the Magna Carta were later incorporated into the Constitution of the United States of America. In 1776, the founders of our country set out to create a system in which men would be entitled to certain inalienable rights, based upon the concepts of the freedoms established in England through the Magna Carta. Initially, African American citizens were not granted equal rights in every area of human life. Descendants of slaves were denied equal access to public facilities, accommodations,

transportation systems and the right vote. to Demonstrations were held in strong opposition to the unfair and unequal treatment African Americans.



the system of justice that provided rights to African Americans, that very same system is being tested by situations like Michael Brown in Ferguson, Trayvon Martin in Miami Gardens, Tanisha McBride in Detroit, Tamir Rice in Cleveland and Eric Garner in New York City. It seems as if everyone does not understand or apply equally to all citizens the principles of justice and freedom.

As we celebrate these milestones in history, we are being reminded as a society about how fragile the balance is between enforcing the law and protecting the rights of citizens. Under the Magna Carta, the rights of citizens were prominent, and yet today the same system of justice designed to protect and preserve the basic liberties described in the Magna Carta is under siege. The problem is that our forefathers did not consider the impact of the institution of slavery on the values and behaviors of people in the justice system. The emotional and systemic psychological damage done to both groups of people who benefitted from, and those who were subjected to enslavement is being revealed today by racism in our criminal and civil justice systems. These monumental acts have shaped who we are as a society. If we fail to make adjustments to the system, to address the actual impact of racial and discriminatory biases, then the types of civil liberties envisioned 800 years ago in the Magna Carta will never truly belong to all people. As members of the justice system, we must review and analyze the systemic failures and the basis for the same. We must ensure that we are preserving in practice, the rights granted to all people in society in each of the declarations whose anniversaries we celebrate this year.

Please join the State Bar on March 30th at a Symposium celebrating the Magna Carta and its impact on the formation of the American system of justice. We are also working with the National Center for Civil and Human Rights to produce a series of public events to celebrate and remember the actions of people who made sacrifices for civil rights in addition to the celebration of the passage of premier Voting and Civil Rights Acts. Look out for more details on these events in the months to come.


